From the President

- 1. The Association is having continuing discussions with the Kingborough Council on:
- Development of Taroona Park and associated beach areas.
- The possibility of designating a portion of one of our beaches as a "Dog Walking Beach".
- The Future of Chiton Chase our current view is that this road should remain open and be developed as a tourist asset and an alternative access to the Taroona Beach area (the road surface, drainage and speed control are issues to be resolved).

- 2. Activities at Mary's Grange and the possibility of closure of the Taroona Child Health Association premises are reported in more detail further on in this Newsletter.
- 3. Safety on our roads and footpaths was discussed at a recent Committee Meeting. Care needs to be exercised by all users – drivers, cyclists, skate-boarders and pedestrians.
- 4. A member of the Association recently commented on vegetation partially blocking footpaths and obscuring letter boxes we can all assist with this matter.

Your Committee welcomes comment on the above and other issues of concern to residents.

Mary's Grange - Development of Future Services

Mary's Grange Nursing Home has provided care to the frail and elderly for almost 40 years. It continues to provide care to 88 residents with residential care-service and community services to 20 clients through the Outreach Service.

As an expansion of services to the elderly, "Reachout" was established some four years ago to encourage people to improve their health and well-being by participating in specifically designed exercise and social programs. These activities have been very popular, attracting in excess of 500 participants each month.

More recently Mary's Grange has purchased the St. Josephs property at 26 Channel Highway, Taroona, which will be used to further its mission in the care for the elderly. It is intended that Independent Living Units be constructed in a retirement village atmosphere for the elderly. The Board of Mary's Grange have under consideration a number of different concepts. The concept will include a Community Centre and two and three bedroom units in a landscaped garden setting. The units will capture views of the river Derwent, and be equipped with appropriate security and services to meet the requirements of the senior citizens of our community. It is envisaged that Council approval will be sought in the next month or so and, once obtained, the units will be available for sale prior to construction.

The purchase and development of St. Josephs presents a wonderful opportunity for Mary's Grange to be able to utilise a site close to its current operations for the benefit of the Taroona Community.
