# Financial report -

On March 2nd 2017 the TCA had a balance of \$4132.48

Since my report of 1 February there has been interest of \$1.44 on March 1st, cheque 527064 for \$45 for Domain name and cheque 527065 for \$78.60 for trailer registration were presented and \$30 was received from Frank Lawrence for membership last year, this year and next year.

There are currently 48 financial members.

There has been a change of rules and the TCA is no longer required to undergo a yearly audit, instead we can simply complete an annual return. Anne and the committee agreed we would continue to undergo an audit, particularly as it provides external recognition we have things in order.
