- 1. School bus stop pedestrian crossing concept (Fiona/Jill)
  - Upgrade of city bound bus stop (safer and more accessible). New shelter and traffic lights
  - Roger raised issues traffic lights on a bend? Also need to address other
    pedestrian crossing areas in Taroona Morris Ave, Stewart Cres, and Oakleigh
    Ave need crossings (they lack sight lines). Some errors in the concept info.
  - Singular approaches may not fix the school crossing issue.
  - Potential to resolve issue at school turnoff too and address the right from the High School road into Channel Hwy?

# **Items for information**

#### 2. Taroona Beach Amenity Building upgrade (Dal)

- Dal spoke with a local engineer. Rather than knock it down, look at options for reusing the building. There are a few options. Slab is good. But a lot of it doesn't work well and it is not very welcoming, e.g. have to walk into change rooms to go to the bathroom need to separate those, and provide disabled toilets (e.g. similar to Long Beach). Reuse is doable (and cheaper and less wasteful). Can cut holes in walls and ceiling easily to bring in light. Could add nice tiles etc.
- Complaints dark, breezy. Too much concrete.
- Council have been contacted by TCA. We have expressed support in considering reuse options.

# 3. Track maintenance throughout Taroona (Fiona)
