# 2 Review of actions from previous meeting

**IMAS** – Jill, Alison and Nigel (Taroona Environment) met with IMAS and Antarctic Div representatives to discuss plans for the Taroona IMAS site.

Plan to move Krill breeding research facility and tanks from Ant Div. Will build an upgraded facility in Taroona with new labs and meeting rooms etc and a large car park (55 cars). Reps described the Kingston Ant Div site as antiquated and not fit for purpose. Jill asked for plans for the site, but we have not seen them yet. A 3-storey building will be built but dug in so that it is more like 2 storey, located between the old cottage and the fence line near the fire station. A total of 29 trees will be cut down, 15 trees with a low conservation classification and 14 with a high or very high conservation classification will be cut down.

Jill et al highlighted the key concerns for the community are about increased traffic and the loss of trees. Jill argued for a public meeting in early July to be transparent with the community and IMAS want to put something in the newsletter. We agreed a meeting notification should go in the newsletter. Jill will contact Liz to discuss newsletter dates.
