### **TAROONA COMMUNITY ASSOCIATION FINANCE REPORT For February 2022 (Anne)**

On February 23<sup>rd</sup>, 2022 the TCA had a balance of \$1113.66

Since my report of November 24th, 2021, we have had \$4.63 interest, \$10 donation and 6 new memberships, plus \$600.08 from the TVFB. Cheques 527115, 527116 and 527117 for \$66 (Consumer affairs), \$5800.06 (TVFB solar panels) and \$903 (Public liability insurance) have all been presented.

We have \$533 left from our Neighbourhood grant to go towards the planned bird bath and seating.

This means we effectively have \$580.66

There are currently 45 financial members.
